TARGET AUDIENCE

The ACLS Provider course is designed for healthcare providers who either direct or participate in the resuscitation of a patient, whether in or out of a hospital. In this course you will enhance your skills in the treatment of arrest and peri-arrest patients through active participation in a series of simulated cardiopulmonary cases. Because of recent changes in the course, **students must be proficient in rhythm recognition, pharmacology, and BLS skills and knowledge. These will not be taught at the course.**

ADMISSION

A current ACLS card is required to participate in the Refresher course. **Please enclose a current copy of your ACLS card with your application for the ACLS Refresher course.**

LOCATION

The **Marquette General Hospital Conference Center** is located in the East Building, also known as the 1984 Building. Park in Lot A, which is located at the corner of Hebard Court and College Avenue. Enter the hospital through the East Entrance canopy and take the elevator to the third floor and exit to the right.

Although participants of ACLS programs are not required to practice, it is strongly recommended. Opportunity to review pharmacology, ACLS algorithms, and cardiac rhythm interpretation will be available at the "Early Bird" practice session on March 5, 6:00 to 8:00 p.m.

BCLS recertification will not be offered.

ACLS requires the participant to know BLS skills. This skill will be tested during the ACLS course.

Attendees with little or no experience in cardiac rhythm interpretation are **strongly encouraged** to attend a rhythm recognition course before ACLS.
